Beginning of a New Year!

It's hard to believe the first quarter of Pheasants & Quail Forever's Fiscal Year has already escaped us, but in the process there were a lot of great things that have happened. July was a busy month assisting NRCS field offices with Monarch WHEG's and planning assistance for the Monarch Initiative, attending NRCS' Conservation Planning Course, conducting site visits, and providing wildlife habitat assistance to landowners. A couple site visits had partners from NRCS, ODWC, and NWTF which was an opportunity to build relationships and provide valuable insight to landowners. Although most of this seasons field work has wrapped up for the Monarch Initiative and other NRCS programs, it is time to switch gears and work to educate on wildlife habitat management and promote available wildlife driven programs to landowners.

I have also been participating in the Oklahoma Monarch & Pollinator Collaborative (OMPC) Steering Committee monthly conference calls. Within this group, I have taken on the leader role of the "Lands Work Group" and actively working on producing an Oklahoma Best Management Practices (BMP) document to

post on the Okies for Monarchs website. This will allow landowners to have access to critical information in regards to managing for monarchs/pollinators. My involvement with this group is really starting to show some fruit in the form of additional landowner contacts that I would not have been exposed to otherwise.

Okies on the Rise

Finally, to round out the quarter. In partnership with NRCS, PF/QF has concluded interviews for two new Farm Bill Biologist positions in Oklahoma, which will take us up to four full-time biologists to better assist landowners across the state. These two new positions will be located in Claremore and Woodward. We are thankful for this opportunity and look forward to all the great things this next year will bring.

Photo from a growing season burn workshop hosted by Noble Research Institute near Marietta, OK. This was the 2nd of two burns conducted that day. Great opportunity to assist with and learn more about growing season burns and the benefits that can come from them. Fire behavior between the two burn units were quite different even though the sites were less than 10 miles apart.

Training/Meeting Type	Outcome
Oklahoma NRCS Conservation Planning Course	Learned the importance of following NRCS 9-Step process to Conservation Planning, inventory tools/methods and a basic understanding of all the aspects within NRCS.
PF/QF District Meeting	Meeting in Duncan, OK to discuss the upcoming year and what to expect. I also gave an update on the Monarch RCPP and what that project looks like moving into the next Fiscal Year.
Summer Burn Workshop; Noble Research Institute	Excellent workshop that sparked a lot of great conversation among the group. We also had the opportunity to assist with two different prescribed burns, both of them being very different in behavior and exposed the group to a lot of variables that would not happen in just the classroom.
Precision Ag Roundtable/ Workshop	Roundtable discussion with producers and Precision Ag representatives in Grant County to discuss Precision Ag and how it can be utilized to help producers meet their bottom line and also provide valuable wildlife habitat.
Oklahoma NRCS Zone Technical Committee Meeting	Attended meeting with Mike Sams to discuss Monarch and Pollinator technical notes and seed mix calculators associated with each. Took feedback and assisted in revision of seed mix calculators to better assist field office Conservation Planners.

What a Year!

I can't believe I joined the Oklahoma team a year ago! The past 14 months have flown by. I am grateful for all the opportunities to learn from the partners and look forward to learning much more.

July found me continuing my education of NRCS with conservation planning at Stillwater. The course gave me the opportunity to meet other partner biologists in addition to learning the proper methods for NRCS conservation planning. I also spent time wrapping up Monarch and Lesser Prairie Chicken Initiative habitat management and grazing plans.

In the beginning of August, I was honored to participate in a Growing Season Prescribed Fire Field Day hosted by the Noble Research Institute. There is no better teacher than experience and the field day provided it! Participants were able to assist on two burns totaling 54 acres. The burns were very different and showed just how important fuel composition and fuel moisture are when planning a burn. The afternoon burn acted like a dormant season fire because of the hot temperatures and low fuel moisture. Overall, it was a very educational day in the field and I hope to use that knowledge to encourage others to implement growing season burns.

professionals, farmers, and PF/QF staff. We covered everything from the challenges in getting producers on-board to the dollars gained by implementing new practices. Several local chapter members are going to work on a small pilot project to demonstrate not only the benefits to the farmers' bottom-line, but also the upland birds we all love to see. Often times, by "farming the best and leaving the rest", producers can increase profits while improving wildlife habitat. Precision Agriculture programs have gained popularity in other states, but this will be the first initiated solely by local chapters.

NRCS UTV operators training	This required NRCS course provided instruction and competence testing for Staff that will utilize UTVs in the field.	
NRCS Conservation Planning	Biologists and staff in partnership positions with NRCS gathered in Stillwater for instruction on conservation planning for NRCS. This is a requirement for apprentice level certification.	
Quail Forever District Meeting	Chapter members from NW Oklahoma met in Enid for an overview of FY18 and planning for FY19. I provided a brief overview of the FBB program and my activities over the spring.	
Growing Season Prescribed Burn Field Day	Noble Research Institute hosted a field day to discuss and practice prescribed burning during the growing season. Participants conducted two burns totaling 54 acres.	
Precision Agriculture Round Table	PF/QF staff met with local chapter members, farmers, and local professionals to discuss Precision Agriculture in Oklahoma. A small chapter-led pilot is starting in North Central Oklahoma to investigate the potential of precision agriculture.
